"hold" for a max of 6 months, during which time no membership dues will be drafted. To place a membership on hold, **Hold Form must be received by the 20th of the month prior** to the next draft date. Membership rates may increase every January 1, and will be communicated via electronic newsletter and website at least 60 days in advance. The YMCA is not responsible for personal property lost, damaged or stolen while using the YMCA facilities or participating in YMCA programs. Information given to the Y is the property of the YMCA and is kept as confidential information by the Y and its representatives. Video and camera equipment, including cell phones, may not be used in locker rooms or restrooms. Membership to the Y is a privilege, and the Y reserves the right to cancel a membership at any time as deemed necessary. Membership privileges and cards are not transferable. Members or participants with a balance noted on their account cannot rejoin, use the facility, or participate in programs until it is paid, or a payment plan is established. This does not apply to youth 17 and under paying for a day pass or new Youth Memberships. **Since it is contrary to the mission of the YMCA to be a sex offender, the YMCA will deny or revoke a membership for anyone with this status.** The YMCA upholds a strict zero-tolerance policy for sex offenders and individuals convicted of child abuse.

☐ **Membership rates will increase when a member ages into a different membership type at age 18 (Young Adult) and 26 (Adult), and will decrease at 62 (Older Adult).** Increases will be communicated via paper mailing 60 days in advance and email 30 days in advance.

☐ I give permission for the YMCA (local, national and international) to use, without limitation or obligation, **photographs, videos, or other media** that may include my image or voice to promote the YMCA and its programs.

☐ I accept all provisions of membership set forth in this agreement and hereby agree to a membership.

☐ I will comply with the Winona Family YMCA's **Code of Conduct** [winonaymca.org/policies](http://winonaymca.org/policies).

☐ I attest that no one listed on this membership application has been **accused or convicted of any crime involving a sexual offense or child abuse.**

### Liability & Indemnity Waiver

IN CONSIDERATION of being permitted to utilize the facilities, services and programs of the Winona Family YMCA (or for my children to so participate) for any purpose, including, but not limited to observation or use of facilities or equipment, or participation in any program affiliated with the Winona Family YMCA, the undersigned, for himself or herself and such participating children and any personal representatives, heirs, and next of kin, hereby acknowledges, agrees and represents that he or she has, or immediately upon entering or participating will, inspect and carefully consider such premises and facilities or the affiliated program. It is further warranted that such entry into the Winona Family YMCA for observation or use of any facilities or equipment or participation in such affiliated program constitutes an acknowledgement that such premises and all facilities and equipment thereon and such affiliated program have been inspected and carefully considered and that the undersigned finds and accepts same as being safe and reasonably suited for the purpose of such observation, use or participation by the undersigned and such children. The undersigned is aware of the different types of activities, equipment, and facilities offered by the Winona Family YMCA and is aware of the risks inherent in the participation in such activities and use of such equipment and facilities. IN FURTHER CONSIDERATION OF BEING PERMITTED TO ENTER THE WINONA FAMILY YMCA FOR ANY PURPOSE INCLUDING, BUT NOT LIMITED TO OBSERVATION OR USE OF FACILITIES OR EQUIPMENT, OR PARTICIPATION IN ANY PROGRAM AFFILIATED WITH THE WINONA FAMILY YMCA, THE UNDERSIGNED HEREBY AGREES TO THE FOLLOWING: **1.** THE UNDERSIGNED ON HIS OR HER BEHALF AND BEHALF OF SUCH CHILDREN, HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the Winona Family YMCA and all branches thereof, its directors, officers, employees, and agents (hereinafter referred to as "Releasees") from all liability to the undersigned or such children and all his/her personal representatives, assigns, heirs, and next of kin for any loss or damage, and any claim or demands therefor on account of injury to the person or property or resulting in death of the undersigned or such children whether caused by the negligence of the Releasees or otherwise while the undersigned or such children is in, upon, or about the premises or any facilities or equipment therein or participating in any program affiliated with the Winona Family YMCA. **2.** THE UNDERSIGNED HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the Releasees and each of them from any, loss, liability, damage or cost they may, incur due to the presence of the undersigned or such children in, upon or about the Winona Family YMCA premises or in any way observing or using any facilities or equipment of the Winona Family YMCA or participating in any program affiliated with the Winona Family YMCA whether caused by the negligence of the Releasees or otherwise. **3.** THE UNDERSIGNED HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE to the undersigned or such children due to negligence of Releasees or otherwise while in, about or upon the premises of the Winona Family YMCA and/or while using the premises or any facilities or equipment thereon or participating in any program affiliated with the Winona Family YMCA. **4.** THE UNDERSIGNED further expressly agrees that the foregoing RELEASE WAIVER AND INDEMNITY AGREEMENT is intended to be as broad and inclusive as is permitted by the law of the State of Minnesota and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect. THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THE RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT, and further agrees that no oral representations, statements or inducement apart from the foregoing written agreement have been made.
